For valuable consideration received, I grant to the Photographer and their agents, representatives, employees, heirs, licensees, successors, assigns, and those acting under their authority and permission (collectively "the **Representatives**") the irrevocable, worldwide, perpetual, and unrestricted right and permission to take, use, sell, and publish photographic portraits and/or images of me, in whole or in part; this includes photographic portraits and/or images of my appearance, likeness, form, and voice, and any related film, negatives, transparencies, prints, digital information or recordings ("the **Pictures**").

I specifically agree that the Pictures may be used without any restriction as to changes, alterations, or reproduction that includes but are not limited to being cropped, retouched, processed, composited, distorted in character and form, and/or combined with other images, works, text, graphics, film, audio, audio-visual works and all variations thereof now known or to be invented, and may appear in still, single, multiple, moving, or video format or reproductions, with or without colour ("the **Works**").

I agree the Photographer and Representatives may use, reuse, publish, republish, produce, reproduce, and license the Pictures and/or Works for any purpose (except pornographic or defamatory) in any medium and in all media specifically including but not limited to print media, television, digital, electronic and distribution over the internet. Uses of the Pictures and/or Works include but are not limited to the purposes of illustration, promotion, art, editorial, advertising, trade, packaging, marketing, promotion or any other purpose whatsoever ("the **Uses**").

I waive any right that I may have to examine or approve the Pictures, Works, or Uses. I acknowledge that I have no rights, ownership, or copyright to the Pictures, Works, or Uses, and I waive any rights to sell, license, or publish any of the Pictures, Works, or Uses to any person or entity, whether for commercial use or not, without **prior written consent** of the Photographer and Representatives.

I acknowledge that I **may only use** the Pictures and/or Works for my own personal, fan, and social media modelling portfolios (printed and digital) as well as talent/agent websites, and my business cards, but that I have no right to alter the Pictures and/or Works in any way (aside from cropping for print or digital media) including applying creative filters. I agree that the final Pictures and/or Works should remain as they are, and any unretouched portraits and/or images are not for public use. I acknowledge that I must always give the Photographer a photo credit and leave all applicable watermarks on supplied Pictures and/or Works intact and uncropped.

I acknowledge and agree that the Photographer and Representatives can choose to use and publish my Alias and/or social media Profile Name in connection to any Pictures, Works, or Uses. I acknowledge that it is my responsibility to provide the Photographer with an Alias, and the Photographer and the Representatives are not liable for any claims, demands, losses, or damages where the Alias and/or social media Profile Name is synonymous with, or linked to, my Full Legal Name. I also specifically acknowledge and agree that the Photographer and the Representatives may publish the Pictures, Works, and Uses to any photo contests of their choosing as well as on their own portfolio (printed and digital) as well as on any social media pages, groups or profiles associated with them and may tag me using my Alias and/or social media Profile Name (past, present or future). I acknowledge and agree that it is my own responsibility to manage my own social media and settings.

I acknowledge that, excepting for my Alias and/or social media Profile Name, my personal information will not be made public, but it may be used directly in relation to the licensing of Pictures, Works, or Uses where necessary (e.g. to defend claims, protect rights, or notify trade unions).
